Senate-107[2021]-01: Welcome to the members and invitees by the Chairman, Senate.

The Director and Chairman, Senate welcomed all members and invitees to the 107th (Emergency) meeting of the Senate conducted in online mode through MS-Team.

Senate-107[2021]-02: To discuss the restoration of studentship of Sri Nishant Nihar, Roll No.712EE1073.

With regards to the agenda item for restoration of studentship of Sri Nishant Nihar, a detailed deliberation was made by the Hon'ble senators with the context of the appeal made by Mr. Nishant Nihar to the Chairman, Senate about his health issue for which he could not fulfill the necessary academic formalities for his continuance of studentship.

Senators were unanimously sympathetic on the issue and were very much considerate towards Mr. Nishant Nihar to restore his studentship and allowed him to register all the 5th semester theory subjects & left over 9th semester subjects in Autumn 2021-22 to complete the program in accordance to the rules and procedure of NIT, Rourkela. Further it was discussed that he need not register again for the lab subjects of 5th sem, as his lab subjects have already been graded through continuous evaluation.

Senate aspects, the grievance of the student through his appeal is dully considered in his favour and without any prejudice. Hence, it is expected he should not go to any other forum further.

Senate-107[2021]-03: Any other matter with permission of the Chair.

Item-1: Restoration of studentship of Raja Mohan Singh.

Mr. Ramesh Babu father of Mr. Raja Mohan Singh (117CR0709) appealed to senate chairman after receiving the termination notice from the institute as the student scored less than 6 CGPA in consecutive four semester. He appealed that his ward had severe depression in semester beginning and had been hospitalized. The Institute Counseling Services (ICS) also verified it (NIT health centre doctor's prescription). ICS stated that the

student had taken counseling from ICS doctor & counselor and was under medication where after he showed improvement. The student has 5.98 CGPA now. Considering the fact that he was actually under depression in his semester beginning and has been showing improvement.

Under the stated circumstances, the senate was considerate and allowed him to continue his studentship and register for 7th semester in Autumn – 2021.
