The contractors should produce certificate of satisfactory completion of similar works from organization for whom the works have been executed. Only contractors pre-qualification under this procedure will be invited to bid at a subsequent date.

The pre-qualification shall be based on an objective evaluation of details regarding past performance, Technical and Financial capabilities and resources of the contractors with proven track record in building construction projects and will be evaluated by the NIT.
