A firm may opt to be considered for:

(i) Both groups together, (ii) Group – I only, (iii) Group-II only, (iv) Group -I or Group – II or (v) Group - I or Group – II or both.

Those firms who have already applied for prequalification, vide Tender Notice No. – 04 of 2010-11 may give their consent for the group of buildings they would like to be considered. Qualifying for any group of buildings, the firm should have satisfactorily completed similar works especially educational institute buildings of value not less than Rs. 70 crores in the last five years and at least one single building work costing at least Rs. 45 crores in a period of 24 months. The average annual turnover of the contractors on buildings should not be less than Rs. 100.00 crores over the last five years. For both groups together, a firm must have financial record equal to twice of these listed above. The contractors should produce certificate of satisfactory completion of similar works from organization for whom the works have been executed. Only contractors pre-qualification under this procedure will be invited to bid at a subsequent date.

The pre-qualification shall be based on an objective evaluation of details regarding past performance, Technical and Financial capabilities and resources of the contractors with proven track record in building construction projects and will be evaluated by the NIT.

When the works are put on tender, the tender committee will examine all combinations:

- a) Both groups of buildings to a single party, or
- b) Two groups of buildings to two separate parties and will accept the most economical solution. Firms will be invited to quote prices for each group separately and for both groups together. Only those firms will be qualified to quote for two together who financially qualify for work of Rs. 180 crore. In case of a tie, preference will be given to a party with highest average annual turnover.
