The National Institute of Technology, Rourkela intends to invite offers from leading Consultants (Government, PSUs and private agencies of repute) for providing Project Management Consultancy (PMC) services for construction of its Technology Innovation & Industrial Relation Building, costing about Rs. 28.00 crores, involving civil, structural, architectural, electrical, sanitary, plumbing, HVAC, fire fighting works etc. The contract for the work has already been awarded and the above work has just started. The task includes planning of resources, supervision and monitoring of progress and quality; control of all activities involved in the process, using latest methods of Management Information System, CPM – PERT charts-etc; measurement of works including joint measurement with the contractor and institute staff, checking of bills for payment to agencies, maintaining of site registers/ records, and other documents as required for the work, submission of monthly progress reports; ensuring full compliance with engineering design, drawings, technical specifications and other contract documents etc. The consultant should also coordinate with the concerned Architect, the contractor and NIT (Rourkela) officials and ensure timely & successful completion of the work. The consultant should also furnish replies to Chief Technical Examiner/Audit/Central Vigilance Commission, if any, pertaining to its scope of services.

The consultant must have relevant experience in the field of construction supervision and quality control, quality audit works.
