(Appointment of Architect for Master Plan & other Projects (Phase-III) (Civil, Electrical &HVAC) for NIT, Rourkela.

Sealed tenders are invited from leading Architects for providing comprehensive architectural services for the following projects to be taken up in NIT costing about Rs.300.0 crores to be executed in a phased manner spread over about 5 years. It is intended to award the entire work to a single Architect. Those architects who had applied earlier vide our Tender Notice No.13 of 2012-13 may give their consent for consideration.

1. Eligibility Criteria.

Architects who fulfill the following requirements(documentary evidence to be submitted) shall be eligible to apply. Joint ventures are not accepted.

i) Should have successfully completed similar works during the last seven years ending 31-12-2012, satisfying either of the following:

• Three similar completed buildings each costing not less than Rs.60.00 crore.

Or

• Two similar completed buildings each costing not less than Rs.80.00 crores.

Similar work shall mean construction of RCC frame structure building including plumbing, electrical, firefighting and HVAC works.

ii) Should have successfully completed at least one institutional building costing not less than Rs.100.0 crores.

iii) Should have successfully completed Master Plan of any Educational Institute/University of approx. built up area of minimum 100 hectare.

iv) Should have successfully completed at least one Auditorium of 1000 capacity.

v) Should have successfully completed at least one 6 storeyed building.

vi)Should have had average annual financial turnover of Rs. 3.00 crores on comprehensive architectural services during last 3 years, ending 31st March 2012(Copy of certificate from CA to be submitted)

vii) Information regarding projects in hand, current litigation, orders regarding extension or blacklisting, if any should be indicated.

viii)A Committee based on the information to be submitted by the Architect, will assess their capacity to take up the proposed project under consideration to complete in time.

2. The task includes comprehensive architectural services, i.e. designs, drawings including detailed construction drawings, estimates of cost for civil, plumbing, electrical, firefighting, HVAC and development works. The task will not include project management. However, the Architect shall deploy one junior Architect at site for co-ordination and giving necessary decisions. Interested Architects, registered with the Indian Institute of Architects/ Council of Architects who have executed similar type and value of work are requested to apply with credentials/information/testimonials addressed to the Registrar, NIT, Rourkela – 769008, in sealed envelopes, **Envelope No. - I**: to contain techno-commercial bids, financial capability including details of organization, experience, copies of work orders, testimonials etc. **Envelope No.- II**: to contain the price bid as percentage of the project cost in the prescribed form. For Master plan, the same percentage will be applicable over the project cost of road, drain, external electrification works. Both of these envelopes should be enclosed in one cover envelope superscribing on the top of the envelope:

3. The selection of the Architect will be decided on the recommendation of an expert committee after scrutiny and presentation by prospective bidders. A combined quality cum cost criterion will be used for the selection as per guidelines of 'Manual on Policy & Procurement of work', Ministry of Finance, Govt.of India.

4. There will be a penalty clause for delay in issue of drawings/decision by the Architect which will be operated at the decision of the Institute Management. The Institute should not be required to state reasons for any such decision.
