Terms and conditions:

- 1. **Inspection of materials**: This can be done by contacting Prof. P.K.Ray (ME), for above materials within the above stipulated period.
- 2. Submission of sealed bids:
 - a) The bids should be sent by Speed Post only in the name of **Registrar, NIT Rourkela-769008,** superscribing the text **"Tender for disposal of miscellaneous scrap materials" and tender number,** on the top of the envelope. The minimum bid value is Rs. 8,00,000/- (Rupees Eight lakh only).
 - b) The E.M.D of Rs.40,000/- (Rupees Forty thousand only) must be enclosed along with the bids. Bids not accompanied by the earnest money will be liable for rejection. For unsuccessful bidders, the E.M.D will be returned within one week of finalization of the tender.
- 3. **Payment:** The full payment must be deposited by **27th May 2014** by 5.00 P.M. Earnest money will not be adjusted for this but will be converted in to security deposit.
- The successful bidders will have to lift the <u>ENTIRE MATERIAL</u> & <u>CLEAN</u> <u>THE SITES</u> before 4th June 2014. In case of failure to do so the security deposit shall be forfeited and next eligible bidder shall be offered.
- 5. The security deposit will be released only after the entire transaction is completed to the satisfaction of the authority, which includes lifting of the ENTIRE MATERIAL & CLEANING THE SITES. If the material is not lifted or the area is not cleaned to the satisfaction of Institute authority within the stipulated period, the security deposit shall be forfeited.
- 6. If during the process of lifting materials, any bidder is found to damage Institute property, he will be liable to pay the cost of repair, as assessed by the Institute.
- 7. Employees of the Institute, Individuals related to them and organizations in which Institute employee hold stake are not eligible to quote.
- 8. All payments are to be made in the form of bank drafts drawn on any bank in Rourkela and made payable to the Director, NIT Rourkela. On the reverse side of the draft the name company/bidder should be written along with the tender number.
- 9. The Institute reserves the right to accept or reject any offer OR cancel the tender altogether, without assigning any reason thereof.
- 10. In all matters the decision of the Director, NIT Rourkela will be final and binding.
