items within the above stipulated period.

### 2. Submission of sealed quotations:

- a)The quotations should be dropped in the "Drop- box" kept in the office of the Security Officer in the name of Director, NIT Rourkela- 769008. Attention: Security Officer super scribing the envelope "Tender for Disposal of Bicycles", on the top of the envelope.
- b) The E.M.D must be deposited along with the quotations. Quotations not accompanied by the earnest money will be liable to rejection. For unsuccessful bidders, the E.M.D

- should be collected from the office of Security Officer within one week of finalization of the tender.
- 3. Payment: The full payment must be deposited by 13.01.2016. Earnest money will be adjusted for this and extra payment, the H1 bidder has to deposit DD in the office of Security Officer before handing over of the goods.
- 4. The successful bidders will have to lift the ENTIRE ITEMS "As is where is basis" on or before 14.01.2016. In case of failure to do so the security deposit shall be forfeited and next eligible bidder shall be offered the bid at the bidding price of the first bidder.
- 5. The security deposit will be released only after the entire transaction is completed to the satisfaction of the authority, which includes lifting of the ENTIREMATERIAL and cleaning the space. If the material is not lifted or the area is not cleaned to the satisfaction of Institute authority within the stipulated period, the security deposit shall be forfeited.
- **6.** If during the process of lifting materials, any bidder is found to have damaged the Institute property, he will be liable to pay the cost of repair, as assessed by the Institute.
- **7.** Employees of the Institute, Individuals related to them are not eligible to quote.
- **8.** All payments are to be made in the form of bank drafts, drawn on SBI, NIT Campus branch, Rourkela (Code-2109) and made payable to the Director, NITRourkela. On the reverse side of the draft the name company/bidder should be mentioned.
