Performance Security: Performance Security is INR 1,00,000 (Rupees One Lakh Only) in shape of Bank Guarantee/Demand Draft(DD) in favor of Director, NIT Rourkela Payable at Rourkela from any Scheduled Commercial Bank except Co-operative and Gramin bank. It should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligation. BID DOCUMENT

1. Instructions to the bidders

- 1.1 Bids are invited on behalf of the Director, National Institute of Technology (NIT), Rourkela–769 008, Odisha, from the intending bidders for supply of the goods/stores/ equipment for the Institute as detailed in the enquiry letter.
- 1.2 The bidders should quote their offer/rates in **BOQ** in clear terms without ambiguity.
- 1.3 In case of any discrepancy between the rates in figures and that in words, the rate in words will be accepted as correct.
- 1.4 The last date for receipt of the bid is marked in the enquiry.
- 1.5 The bids should be uploaded in https://eprocure.gov.in/eprocure/app Please follow the guidelines of the site.
- 1.6 If a prospective bidder requires any clarification in regard to the bidding documents, he may make a request the concerned officer or faculty member at least 10 days before the deadline for receipt of bids.
- 1.7 Each bidder shall submit only one bid. A bidder, who submits more than one bid, shall be disqualified and considered non-responsive.
- 1.8 In respect of high value plant, machinery etc. of a complex and technical nature, the bids may be submitted in two parts, viz., technical bid and financial bid.
- 1.9 The bidder has to sign in full at all pages of the scanned part of the bidding document. No over-writing in those pages is acceptable.
- 1.10 If any bidder does not fulfill technical specification, his/her eligibility will be cancelled even if his/her price got L1 status.


2. Conditions of the bid

- 2.1 The rates quoted should preferably be net, inclusive of all other incidental charges excluding taxes. In case these charges are quoted extra in addition to the quoted rates, the amount thereof or Ad Valorem rate must be specified. Packing, forwarding, freight, entry tax etc., when quotes separately are reimbursable at actual. If external agencies are employed, their receipts must be enclosed with the invoice.
- 2.2 Duties and Taxes are to be quoted separately. Ad Valorem rates thereof should be clearly indicated with reference to the relevant Acts and Rules.
 - It may be noted that the Institute is availing custom duty exemption in terms of notification no 51/96- Customs dt. 23.07.1996, Notification no. 47/2017- Integrated Tax (Rate) dt. 14.11.2017 and Notification No- 45/2017- Central tax (Rate) dt. 14.11.2017[vid Registration No.: TU/V/RG-CDE (227)/2016, dated: 13.11.2018]
- 2.3 The Services are required to be Provided at Dilip Tirkey Stadium of NIT, Rourkela on 19th April 2019 for Musical Night 2019 starting 6PM.
- 2.4 The bid should remain valid for a period of **90 days** from the date of opening. In case your offer has a different validity period that should be clearly mentioned in the quotation.

- 2.5 Conditional discount, if any, offered by the bidder shall not be considered at the time of evaluation.
- 2.6 The services offered should strictly conform to the specification and technical details mentioned in schedule of requirements of the tender document.
- 2.7 The Institute may like to conduct pre-event inspection of service, where applicable.
- 2.8 Details of Guarantee/warranty, where applicable, should be specified in the bid.
- 2.9 If the successful bidder, on receipt of the supply order, fails to execute the order on the stipulated day, in full or part, it will be open to the Director, NIT, Rourkela to recover liquidated damage from the firm at the rate of 1 percent of the value of undelivered goods per month or part thereof, subject to a maximum of 5 percent of the value of undelivered goods. Alternatively, it will also be open to the Director, to arrange procurement of the required goods/services from any other source at the risk and expenses of the bidder.
- 2.10 The successful bidder may be required to execute a contract, where applicable.
- 2.11 The bidder has to furnish up to date GST and Income Tax Clearance Certificate along with the bid.
- 2.12 Payment (100 percent) will be made by Account Payee Cheque /Bank Draft/Online Transfer, within 30 days from the date of receipt of the goods/services in good condition or receipt of the bill, commissioning of the equipment, and after successful installation and demonstration where ever applicable, whichever is later/latest.
- 2.13 In case of Advance payment, the payment will be made on either in Cheque/Demand Draft or Bank Transfer only. The proforma invoice copy need to be sent for advance payment, if applicable.
- 2.14 In the event of any dispute arising out of the bid or from the resultant contract, the decision of the Director, NIT,Rourkela shall be final.
- 2.15 The bid document/resultant contract will be interpreted under Indian Laws
- 2.16 Please check Other Important Terms and Conditions/Qualification Criteria below.

3. Other Important Terms and Conditions/Oualification Criteria:

- 1. Schedule of requirements contains the requirements/services, whose value will vary according to artists.
- 2. ANNEXURE 1 contains the sketch of venue & ANNEXURE-2 contains the requirements for Sound, Backline, Light, FOH PA SYSTEM, Venue & stage decorations, AV specifications etc.
- 3. Any requirements from the artists' side inside or outside the venue throughout the event should be attended and dealt by the firm itself. No requirements or services, except the venue (Annexure -1) shall be provided by NIT Rourkela.
- 4. All the specifications of the requirements marked in Schedule of requirements should be finalized after consulting the artist/concerned authority.
- 5. NIT ROURKELA shall provide the venue 3 days prior to performance.
- 6. The tender filed should include all the costs as per deliverables mentioned in Schedule of requirements & ANNEXURE-2, **including all taxes applicable** and any other charges added.
- 7. The firm is required to provide its GSTIN number, Company's registration no, previous work details and all relevant supporting documents.
- 8. The institute has the sole right to cancel the event/quotation at any time with/without any prior notice or
- 9. The firm is required to quote against every individual requirement mentioned in Annexure 2. Absence of all technical requirements in the quotation will not be considered though it has the lowest price.
- 10. The award of contract will be purely on the basis of lowest bid (i.e. L1 bid) against individual artist, received from all the parties participating in the Limited Tender Process. There is no preference list for artists and all the artist will be consider with equal priority.
