- 3. NIT Rourkela reserves the right to reject or cancel any tender/bid wholly or partly without assigning any reason.
- 4. The technical committee constituted by the NIT Rourkela shall have the right to verify the particulars furnished by the bidders independently.
- 5. Bidders shall take into account **all costs including supply, packing, delivery, etc. to various departments/sections of NIT Rourkela before quoting the rates.** In this regard, no claim for any extra payment for any reason shall be entertained. The supplier shall be responsible for any damage during the transit of goods.
- 6. There shall not be any price indication in the technical bid. If for any reason, it is found that the technical bid reveals the price bid-related details in any manner whatsoever, the price bid mentioned in the technical part, the bid document will be summarily rejected in the first instance itself.

Bidders registered with Khadi Village Industries Commission (KVIC), National Small Industries Corporation (NSIC), and any other body specified by the Ministry of MSME/GoI as per procurement policy for Micro & Small Enterprises (MSE) order 2012 are exempted categories from payment of EMD provided that the registration certificate issued by any one of above-mentioned agencies must be valid as on closing date of this tender. - 17. The Bidder shall duly fill in all particulars in the format as at Annexure-V and it shall form part of the tender document under Techno-Commercial bid. Tender without duly filled & signed form shall render be considered invalid.
- 18. The bidders may submit duly filled and completed bidding documents Online as per instructions contained in the bidding documents. An incomplete bid shall be rejected. The conditions of the tender shall be governed by the details contained in the complete bid document.
- 19. The bidders must unconditionally accept all terms and conditions stipulated in this Notice, and, all enclosures must be duly filled in, signed, and stamped by the authorized representative. Bid received without a copy of the Notice duly signed and sealed on all pages will be rejected.
- 20. Late and delayed submission of Bids will not be considered. In case any unscheduled holiday occurs on the prescribed closing/opening date the next working day shall be the prescribed date of closing/opening.
- 21. This is a domestic Tender according to the DPIIT OM dated 04/06/2020 and subsequent amendments to the order for Public Procurement Preference and provision FOR LOCAL SUPPLIERS TOWARDS PREFERENCE TO MAKE IN INDIA. Bidders should also give details of Locations(s); at which the local value addition is made. Bidders are requested to furnish the declaration regarding local content/locations in Annexure I.
- 22. Purchase Preference under 'Make in India' Policy for "Local supplier" (OM no: DPIIT order No. P45021/2/2017-PP (BE-II) dated 4 June 2020):

In terms of the above-said policy, only Class-I local suppliers and Class-II local suppliers shall be eligible to bid. Non-local supplier is not eligible to bid. The purchase preference shall be given to Class-I local suppliers only.

- a) 'Class-I local supplier' means a supplier or service provider, whose goods, services, or works offered for procurement, have local content equal to or more than 50%, as defined under said order.
- b) 'Class-II local supplier' means a supplier or service provider, whose goods, services, or works offered for procurement, have local content of more than 20% but less than 50%, as defined under said order.
- c) 'Non-Local supplier' means a supplier or service provider, whose goods, services, or works offered for procurement, has local content less than or equal to 20% as defined under the said order
- d) 'Local Content' means the amount of value added in India which shall be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.
- e) 'Margin of Purchase Preference' means the maximum extent to which the price quoted by a Class-I local supplier may be above the L1 for purchase preference. The margin of purchase preference is 20%.

TERMS & CONDITIONS

- The period of the contract shall initially be for a period of one year with effect from the date of award of the
 contract and may be extendable for two more years on satisfactory performance, under the same terms and
 conditions or with such amendments as may be mutually agreed to, and also subject to the necessary
 approval of the Competent Authority. The entire period of the contract shall not exceed three years unless
 otherwise required.
- 2. Quotation will be evaluated item-wise basis (i.e. fixed rate/rate of discount in %). The purchase committee will evaluate & compare the quotation determined to be substantially responsive i.e.
 - (i) Are properly signed;
 - (ii) Conform to the terms & conditions and specifications;
 - (iii) The prices offered are competitive.

3. The Bidder shall furnish the following documents as part of the Techno-commercial Bid:

The successful bidder will be required to deposit a security amount of Rs. 30,000/- (Rupees Thirty Thousand Only) in the form of a Bank Guarantee or Demand Draft in favor of "Director, NIT Rourkela" Payable at Rourkela and the same should remain valid for 60 days beyond the contract period. The empaneled contractor for chemical rate contract should have to deposit the security amount within fifteen days after the award of contract. No interest shall be payable by NIT Rourkela to the bidder on their Security Deposit. EMD of successful bidder shall be returned only after submission of Performance Security Deposit.

9. TENDER EVALUATION:

The Institute will evaluate the entire tender, strictly based on the terms & conditions incorporated in the tender inquiry document and terms, conditions, etc. as stipulated by the bidder in their tender to determine whether these are compliance in all respects, as specified in the tender inquiry document.

During the evaluation/scrutiny of the tender, at any stage, if it is found that any terms and conditions of tender are not in compliance by the bidder, the Institute may seek clarification within the specified target time and if the bidder fails to reply / or not agree/accept the terms and conditions, their tender will be treated as unresponsive and it is liable for rejection.

The Institute will evaluate the techno-commercial bid. Only those firms will be qualified for financial bid opening whose technical bids are found suitable as per the requirement of the tender. If a participating manufacturer wishes to supply through their authorized dealer, the manufacturer will provide the name of their authorized dealer for supply of Rate Contract items.

10. AWARD OF CONTRACT:

1. SELECTION:

- a. The bidder offering higher discounts will be selected for each brand of chemicals and lab ware.
- b. In case of a tie (equal discount for any particular Chemicals/Lab wares), the firm having an office in Rourkela will be preferred over others.
- c. In case of a tie of both (a) and (b), the older firm, based on the copy of the certificate of incorporation/Registration Certificate of the firm, will be selected for that brand of Chemicals/software.
- d. A panel of bidders/suppliers shall be selected for the Rate Contract, one supplier for each brand of Chemicals/Lab wares.
- 2. The empaneled suppliers will abide by all the Terms and Conditions of the Tender Document.
- 3. The Rate Contract will be valid for a minimum period of ONE YEAR (i.e. from the date of placement of Order), which shall be extended for further two years subject to annual review basis, if the performance of the empaneled supplier is found satisfactory.
- 4. The performance of the empaneled suppliers will be reviewed during the contract period and NIT Rourkela reserves the right to retain or delete suppliers in the list of rate contracts based on performance. No prior Intimation in this regard will be given.

5. NIT Rourkela reserves the right to enter into a Parallel Rate Contract for similar items during the period of the Rate Contract with one or more parties.

11. PAYMENT TERMS:

100% payment for the supply of items will be made to the firm within 30 days of the receipt and acceptance of materials at our site subject to the inspection of materials by the Indenter. No advance payment will be made to the suppliers. No Bill for part payment will normally be entertained. No payment will be made for unsatisfactory supply.

Payment shall be released on receipt of the original bills in triplicate, which shall be completed in all respects accompanied with original delivery challans of all the items duly signed and stamped by the authorized representative of the user department.

The payment being claimed should be strictly in compliance with terms of the contract and all obligations on the part of the supplier for claiming the said payment have been fulfilled as required under the contract.

12. ORDER ACCEPTANCE LETTER:

The successful bidder on the award of the contract/order must send the contract/order acceptance in writing, within 10 days of the award of the contract/order failing which the EMD will be forfeited.

13. DELIVERY SCHEDULE:

- 1. The material should be door-delivered to NIT Rourkela.
- 2. No freight will be paid on this account.
- 3. **Delivery must be made within 30 days from the issue of the order** either directly or through their dealer network unless otherwise specified. Earlier delivery by the supplier is preferred /appreciated. If the ordered material is not supplied in the above-mentioned period, then the NIT Rourkela shall the following right open to it:
 - a) The Institute may procure goods and services from any other firm and recover extra costs incurred, if any, besides penalty from the defaulted supplier.
 - b) Penalty: The date of delivery should be strictly adhered to; otherwise the Institute reserves the right not to accept the delivery in part or full. The liquidated damages @ 0.5% per week or part thereof in respect of the value of order undelivered will be deducted from the price subject to a maximum of 10% of the value of the order shall be imposed and recovered. Alternatively, the order will be cancelled and the undelivered stores shall be purchased from elsewhere at the risk and expense of the firm.
 - c) The Institute may cancel the order / not accept the ordered material.
 - d) The Institute may cancel the Rate Contract, of which a notice of cancellation shall be sent to the supplier in writing.
- 14. The items, so supplied will have to be of high quality and grade and in the inspection/test. If these are found to be of inferior quality, the same is to be replaced by the supplier at their cost within 15 days from the rejection of the materials, failing which the concerned supplier shall be blacklisted and Rate Contract shall be also canceled. Delay supply / non-compliance of complete order may also lead to cancellation of the Contract.

The bidders are bound to supply only genuine branded chemicals, solvents, glassware, lab ware of the make/model/specification and purity gases of the specification etc., ordered by the Department. The Department shall be at liberty to ask for the production of sufficient proof that the manufacturer is rendering adequate business support to the bidder/supplier. The Department will have the right to verify directly with the manufacturer without notice to the bidder for the genuineness of chemicals, solvents, glassware, and lab ware, and also the authority delegated to the supplier.

15. **DISCOUNT:**

Prices must be quoted based on Discount on Net Dealer Price (NDP) for each category of items in terms of Percentage (%) discount on NDP. Additional Dealer Discount may also be mentioned clearly as and where applicable.

**Note: A Bidder shall offer a minimum discount of 10% on MRP.

16. For the permanent/temporary discontinued items, the firm shall intimate the same to NIT Rourkela within 07 days from the date of order; otherwise, the Liquidated Damage clause will be applicable for the discontinued items.

17. TERMINATION OF THE CONTRACT:

The rate contract can be terminated by either party by giving a notice of 30 days. The Competent Authority, NIT Rourkela may decide to terminate the rate contract in the following conditions:

- a) Supply/delivery of faulty/spurious material or material non-compliant with the technical specifications as mentioned in the Purchase Order.
- b) Delay in delivery or being non-responsive will lead to a penalty as imposed by NIT Rourkela.
- c) Temporary Debarment/ Holiday Listing/ suspension/ removal from the list of registered Vendors of the Manufacturer/ supplier by any of the IIT/NIT/CSIR Laboratories/Government Organizations/State Govt./Public Sector Units/ Reputed Private Sector Units.
- d) The bidder agrees that all orders placed against the rate contract up to the period of termination shall be executed by them. Failure to comply with the supply may render the party being put on Holiday listing for a period of up to 12 months.

18. Prior Registration and / or Screening of bidders:

Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder registered with the competent authority. The concerned bidder(s) are required to attach the relevant valid Registration Certificate along with the bid for consideration.

"Bidder" (including the term 'tenderer', consultant or service provider in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.

"Bidder from a country which shares a land border with India" for the purpose of this Order means:-

- An entity incorporated, established or registered in such a country; or
- A subsidiary of an entity incorporated, established or registered in such a country or
- An entity substantially controlled through entities incorporated, established or registered in such a country; or
- An entity whose beneficial owner is situated in such a country; or
- An Indian (or other) agent of such an entity; or
- A natural person who is a citizen of such a country; or
- A consortium of joint venture where any member of the consortium or joint venture falls under any of the above.

The detailed terms & conditions issued from time to time in this regard by Government of India will be applicable. A certificate as per Annexure – II to the above effect must be submitted by concerned bidder(s).

19. CODE OF INTEGRITY FOR PUBLIC PROCUREMENT:

The Purchaser as well as bidder, suppliers, contractors, and consultants should observe the highest standard of ethics and should not indulge in the following prohibited practices, either directly or indirectly, at any stage during the procurement process or execution of the resultant contracts:

- a) "Corrupt practice": making offers, solicitation, or acceptance of bribes, rewards or gifts, or any material benefit, in exchange for an unfair advantage in the procurement process or to otherwise influence the procurement process or contract execution.
- b) "Fraudulent practice": any omission or misrepresentation that may mislead or attempt to mislead so that financial or other benefits may be obtained or an obligation avoided. This includes making false declarations or providing false information for participation in a tender process to secure a contract or in the execution of the contract.
- c) "Anti-competitive practice": any collusion, bid rigging or anti-competitive arrangement, or any other practice coming under the purview of the Competition Act, 2002, between two or more bidders, with or without the knowledge of the purchaser, that may impair the transparency, fairness and the progress of the procurement process or to establish bid prices at artificial, non-competitive levels.
- d) "Coercive practice": harming or threatening to harm, persons or their property to influence their participation in the procurement process or affect the execution of a contract;
- e) "Conflict of interest": participation by a bidding firm or any of its affiliates that are either involved in the consultancy contract to which this procurement is linked; or if they are part of more than one bid in the procurement; or if the bidding firm or their personnel have relationships or financial or business transactions with any official of purchaser who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) bidder from the purchaser with an intent to gain unfair advantage in the procurement process or for personal gain; and
- f) "Obstructive practice": materially impede the purchaser's investigation into allegations of one or more of the above mentioned prohibited practices either by deliberately destroying, falsifying, altering; or by concealing evidence material to the investigation; or by making false statements to investigators and/or by threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or by impeding the purchaser's Entity's rights of audit or access to information.

20. OBLIGATIONS FOR PROACTIVE DISCLOSURES:

- a) The Purchaser as well as bidders, suppliers, contractors, and consultants, are obliged under the Code of Integrity for Public Procurement to suo moto proactively declare any conflicts of interest (coming under the definition mentioned above pre-existing or as and as soon as these arise at any stage) in any procurement process or execution of contract. Failure to do so would amount to a violation of this code of integrity;
- b) The bidder must declare, whether asked or not in a bid document, any previous transgressions of such a code of integrity with any entity in any country during the last three years or of being debarred by any other Procuring Entity. Failure to do so would amount to a violation of this code of integrity;
- c) To encourage voluntary disclosures, such declarations would not mean automatic disqualification for the bidder making such declarations. The declared conflict of interest would be evaluated and mitigation steps, if possible, taken by the purchaser. Similarly, voluntary reporting of previous transgressions of the Code of Integrity elsewhere may be evaluated, and barring cases of various grades of debarment, an alert watch may be kept on the bidder's actions in the tender and subsequent contract.

21. PUNITIVE PROVISIONS:

Without prejudice to and in addition to the rights of the Purchaser to other penal provisions as per the bid documents or contract, if the Purchaser concludes that a (prospective) bidder/supplier, directly or through an agent, has violated this code of integrity in competing for the contract or in executing a contract, the purchaser may take appropriate measures including one or more of the following:

- a) If his bid are under consideration in any procurement
 - I. Forfeiture or encashment of bid security;
 - II. Calling off any pre-contract negotiations; and
 - III. Rejection and exclusion of the bidder from the procurement process.

b) If a contract has already been awarded

- I. Cancellation of the relevant contract and recovery of compensation for loss incurred by the purchaser;
- II. Forfeiture or encashment of any other security or bond relating to the procurement;
- III. Recovery of payments including advance payments, if any, made by the purchaser along with interest thereon at the prevailing rate.

c) Provisions in addition to the above:

- I. Removal from the list of registered suppliers and banning/debarment of the bidder from participation in future procurements of the purchaser for a period not less than one year;
- II. In case of anti-competitive practices, information for further processing may be filed under a signature of the Joint Secretary level officer, with the Competition Commission of India;
- III. Initiation of suitable disciplinary or criminal proceedings against any individual or staff found responsible.

22. INDEMNITY:

The vendor shall indemnify, protect, and save NIT Rourkela against all claims, losses, costs, damages, expenses, action suits, and other proceedings, resulting from infringement of any law about patents, trademarks, copyrights, etc., or such other statutory infringements in respect of all the chemicals supplied by him.

NIT Rourkela reserves the right to recover the cost of any damage/loss caused due to the negligence on the part of the agency engaged.

23. FORCE MAJEURE:

Force Majeure will be accepted on request in writing and on production of adequate proof thereof.

24. LOSS, DAMAGE & SHORTAGE:

NIT Rourkela shall not be responsible for any loss, damage, or shortage during transit. Payment shall be made for materials received in full and in good condition only.

25. Dispute redressal and legal remedy

i. CONCILIATION / ARBITRATION ON DISPUTES:

All disputes or differences arising out of the contract, except disputes or differences for which separate provisions for their resolution have been made in the contract ('excepted matters'), shall be settled by Conciliation or Arbitration in accordance with the Arbitration and Conciliation act 1996 and subsequent amendments thereof. Such dispute shall first be referred to a Conciliator selected mutually by the parties. The Conciliator shall decide the fees / remuneration and the rules of procedure, which shall be flexible. In the event of failure of conciliation, that dispute will be referred to an arbitral tribunal comprising a sole arbitrator to be appointed on mutual agreement of both the parties. The arbitral tribunal shall be free to determine its own rules of procedure, which it shall state at the beginning of the arbitral proceedings and shall follow such procedure thereafter. The seat of the arbitral tribunal shall be at Rourkela, but, if necessary, the tribunal can hold the proceedings at other places, for convenience in recording evidence.

- ii. In the event of failure of conciliation and arbitration, that dispute shall be subject to exclusive jurisdiction of courts at Rourkela, Odisha.
- 26. The institute reserves the right to amend rules in the tender/contract whenever it is necessary and appropriate. Further, the Institute also reserves the right to cancel/reject any or all bids, or cancel the tender, or abandon the procurement process of the service, or issue another identical tender for similar service without assigning any reason thereof.
