Memorandum of Marks of all Examination starting from HSC onwards (Candidates whose results are awaited will be given provisional admission at their own risk and must produce the qualifying marks by 30<sup>th</sup> September 2020 failing which their admission will be cancelled and all fees paid will be forfeited).
3. Course completion Certificate from the Principal/Registrar of the University /Institute in case result is awaited as per Annexure - I.
4. College Leaving/ Migration Certificate from the Institution last attended.
5. Conduct Certificate from the Institution last attended.
6. Three Pass port size photographs (coloured).
