The interview/written process will be online and no need of physical reporting to the Institute. Please contact respective HOD for detailed procedure.

Notes :

- A. Candidates applied under sponsored category, **if selected**, will be required to stay at NIT Rourkela till completion of their programme. For that candidates applied for PhD need to produce leave for at least three years with M.Tech/M.Pharm degree and four years with all

other degrees from the sponsor at the time of admission. Candidates applied for M.Tech(Res) need to produce leave for at least two years from the sponsor at the time of admission.

- B. Candidates working outside Rourkela, will not be considered for Local Sponsored category. If interested, their cases may be considered for sponsored category on production of proper sponsorship certificate.
- C. Category of studentship mentioned in the application will be decided after interview and verification of documents subject to satisfying the scrutiny criteria vis-vis advertisement criteria.
- D. Please check the website for any subsequent update before proceeding for interview.

Candidates called for interview are required to report to the respective HODs(online) at **9.00 AM on 14-08-2020 (Friday)** with the following documents. The selection process may consist of either written or oral tests or both. It is expected that the test/interview will be completed by the end of the day. However, if it will not be completed on the same day, it will continue on the next day (**or 17th Aug 2020**).

1. Signed copy of the application submitted online along with a set of Xerox copies of all certificates/ testimonials to be submitted to the HOD at the time of reporting.
2. Degree / pass Certificates from Class X onwards (Originals & a set of Xerox copies).
3. Marks sheets/Grade Cards of all examinations from Class X onwards (Originals & a set of Xerox copies).
4. GATE/NET/GPAT etc. Score Card, if applicable (Original & a Xerox copy).
5. OBC/SC/ST/PH Certificate, if applicable (Original & a Xerox copy).
6. Sponsorship Certificate from employer in the prescribed format for Sponsored candidates (Original & a Xerox copy).

The scrutiny list displayed above is based on the preliminary scrutiny. A rigorous scrutiny will be done at the time of interview. Hence, before coming for interview, the candidate must ensure that he/she is fulfilling all eligibility criteria both (Scrutiny and advertisement).
