Instructions for admission to MBA Programme for the session 2024-26

Admission of selected candidates will be done on 29th May 2024. For admission, the selected candidates are to be present in person and are required to bring the following documents in original with photo copy (self- attested) of each.

- 1. Print out of the "Online Enrollment Form" & "Address Slip" obtained from http://eapplication.nitrkl.ac.in
- 2. Pass certificate of High school Certificate examination/ Equivalent examination for proof of date of birth.
- 3. Pass Marksheets and Certificate of Qualifying Examination.

- 4. Memorandum of Marks of all Examination starting from HSC onwards (Candidates whose results are awaited will be given provisional admission at their own risk and must produce the qualifying marks by 30th September 2024 failing which their admission will be cancelled and all fees paid will be forfeited).
- 5. Course completion Certificate from the Principal/Registrar of the University /Institute in case result is awaited as per Annexure I.
- 6. College Leaving and Migration Certificate from the Institution last attended (to be retained).
- 7. Conduct Certificate from the Institution last attended (to be retained).
- 8. Three Pass port size photographs (coloured).
- 9. Applicants claiming reservation under SC/ST/OBC/EWS quota (eligibility as per declaration by GOI) are required to produce valid certificate as detailed below at the time of admission failing which their candidature will be treated as General category:
 - a) The OBC and EWS certificate should have been issued on or after 01.04.2024.
 - b) Candidates claiming reservation under OBC quota are required to produce OBC certificate (Annexure-II) and undertaking (Annexure-III) in the prescribed format for admission to academic programmes (and not the format for employment/recruitment).

Disability certificate shall be issued by Medical Board of at least three doctors duly constituted by the State or Central government under PWD Act.(One of the members of the Board should be the specialist in the particular field for assessing Locomotor, Visual disability, Hearing and Speech disability, Mental disorder and Leprosy cured)

- 2. If disability is likely to decrease (temporary type) then, the certificate should be valid up to September 15, 2024.
- 3. For candidature under physically challenged category, candidates only with a minimum of 40% disability is required subject to the condition that the candidate is capable of carrying out all activities related to theory and practical work as applicable to various programmes without any special concessions and exemptions.
- 4. The Medical Officer of NIT Rourkela may assess the Physically Challenged (PH) certificate and the decision of the Medical Officer is final and binding on the candidate.
