The candidates have to send their consent to HOD-HS ([pradhanj@nitrkl.ac.in](mailto:pradhanj@nitrkl.ac.in)) by 26th July, 2021. Thereafter based on the merit list, HOD-HS will communicate the admission offer to selected candidates on 27th July and finally, they will take admission on 29th July.

Online Admission of selected candidates will be done on 29<sup>th</sup> July 2021. Memorandum of Marks of all Examination starting from HSC onwards (Candidates whose results are awaited will be given provisional admission at their own risk and must produce the qualifying marks by 30<sup>th</sup> September 2021 failing which their admission will be cancelled and all fees paid will be forfeited).

3. Course completion Certificate from the Principal/Registrar of the University /Institute in case result is awaited as per Annexure - I.
4. College Leaving/ Migration Certificate from the Institution last attended.
5. Conduct Certificate from the Institution last attended.
6. Three Pass port size photographs (coloured).
7. Applicants claiming reservation under SC/ST/OBC quota (**eligibility as per declaration by GOI**) are required to produce valid certificate as detailed below at the time of admission failing which their candidature will be treated as General category:
  - a) The **OBC certificate should have been issued on or after 01.04.2021.**
  - b) Candidates claiming reservation under SC/ST quota are required to produce SC/ST certificate as prescribed by the Govt. of India.
  - c) Candidates claiming reservation under OBC quota are required to produce OBC certificate (**Annexure-II**) and undertaking (**Annexure-III**) in the prescribed format for admission to academic programmes (and not the format for employment/recruitment).
