MBBS Degree or equivalent qualification included in any one of the Schedules to the National Medical Commission Act, 2019 and must be registered in a State Medical Register or Indian Medical Register.

**B. Desirable Qualification:**

Post Graduate qualification preferably MD in General medicine.

Candidates have to bring a set of self-attested photocopies of their academic and/or experience credentials along with the original certificates, an original Identity proof issued by Government and two passport size colour photographs on the day of interview.

Interested outstation candidates may appear the interview through video conference as per the said schedule by informing through email in advance along with sending the CV (with WhatsApp mobile number), application/cover letter, and scanned self-attested documents of their academic and/or experience credentials to [chairmanmac@nitrrkl.ac.in](mailto:chairmanmac@nitrrkl.ac.in) on or before **14-Feb-2025** by **02:00 PM**. The link for video conference will be provided to the candidates a day before the interview. Interview through video conference shall be conducted for those candidates only who submit the necessary documents before the due date.

3. All Qualification, Experience and Age Limit will be recognized as on **17-Feb-2025**.
4. As an Institute of national importance, NITR strives to have a workforce which reflects an all-India character and hence candidates from all over the country are encouraged to apply.
