The Board further suggested to revise the 2016-17 budget within Rs. 170 Crore which is the expected Grant-in-Aid to be received in the Financial Year 2016-17 and the Budget for 2017-18 in the range Rs. 220-230 Crore.

Further, the Board observed that the Revised Estimate for the Financial Year 2016-17 and Budget Estimate for the Financial Year 2017–18 should be placed before the Board of Governors with the comments of the Finance Committee rather than placing them directly.

SECTION - B: MAJOR ADMINISTRATIVE ISSUES

BOG-52(2017)-06:

Case of Shri S.K. Upadhyay, Registrar (under suspension), NIT, Rourkela.

As decided vide BOG Resolution No.BOG-51(2016)-08 dated 16.12.2016, Shri S.K. Upadhyay, Registrar was made OSD vide Office Order No.NITR/ES/2016/M/3699 dated 30.12.2016 and Prof. S.K. Patel of Mechanical Engineering Department was assigned with the additional responsibility of Registrar. While the Charge Sheet to be issued to Shri Upadhyay was being prepared, on 17.01.2017 he submitted a copy of the order dated 16.01.2017 passed by the Hon'ble High Court, Orissa directing to stay the office order dated 30.12.2016. Accordingly, in compliance to the stay order, the office order dated 30.12.2016 was kept in abeyance vide Office Order No. NITR/ES/2017/M/1171 dated 17.01.2017.

As per same BOG Resolution stated above, a Memorandum of Charges (Charge Sheet) was issued to Shri Upadhyay vide OM No. NITR/DR/2017/M/1014 dated 18.01.2017 and was consequently put under suspension vide Office Order No. NITR/DR/2017/M/1015 dated 18.01.2017 with approval of the Director in capacity of acting Chairperson so as to ensure untampered disciplinary proceedings. Prof S.K. Patel was again assigned with the responsibility of Registrar vide letter No. NITR/DR/2017/M/1016 dated 17.01.2017. All the above development was appraised to all members of the BOG by e-mail on 26.01.2017. All the above related documents were given in the Annexure.

Shri Upadhyay has replied to the Memorandum of Charges vide his letter dated 27.01.2017. Being confidential, this document was provided in a separate booklet.

The Board ratified the suspension order issued to Shri S. K. Upadhyay and authorized the Director to constitute a 2-member enquiry committee consisting of one senior faculty member of the Institute and another one from outside the Institute. The Board further desired that one of the Asst./Dy. Registrars be appointed as Presenting Officer. The further course of action will be decided after the enquiry report is put up to the BOG.

BOG-52(2017)-07:

Matter of Prof. S.K. Agarwal, Chemical Engg.

A departmental proceeding was held against Prof. S. K. Agarwal of Chemical Engg. Dept. in the matter related to closure of Institute Main Gate on 31.10.2010. He was also given an appointment for personal hearing before the BOG in its 47th BOG meeting held on 19.06.2015. After perusal of the inquiry report and personal hearing of Prof. Agarwal, it was decided by the BOG vide Resolution No.BOG-47(2015)-06 dated 19.06.2015 to refer all documents related to his case to Dr. R. K. Bhandari, the then member of the BOG to suggest actions to be taken by the BOG. The Report submitted

by Dr. Bhandari was considered by the BOG in its 48th meeting held on 31.07.2015 and it was advised to issue a warning letter to Prof. Agarwal not to repeat such type of activities in the future. Since the entire minutes of 48th BOG meeting were not confirmed in 51st BOG meeting held on 16.12.2016, the decision could not be implemented.

In the meantime, Prof. Agrawal retired on 31.01.2017 attending the age of superannuation and has been employed on consolidated pay till end of the current academic year, i.e. 30.06.2017. As per provision of the CCS (Pension) rules 1972, his gratuity has been held up and he has been sanctioned provisional pension without commutation.

The Board accepted the report of the then BOG member Dr. R.K. Bhandari and in view of the fact that Prof. Agarwal has already superannuated, resolved to close the above matter.

BOG-52(2017)-08:

Admissible Allowances for Employees of the Institute.

As per the Statutes Clause 24(iii) provides that the employees of the Institute shall be entitled to allowances in addition to pay, as admissible to Central Government Employees. Accordingly, it is proposed that allowances as admissible to Central Government Employees from time to time may also be extended to the employees of the Institute based on the Office Memorandums issued by Govt. of India.

The Board approved that all the allowances admissible under Orders of the Central Government which specifically mention that they are applicable to the employees of the Centrally Funded Autonomous Organizations be implemented by the Director under information to the FC and the BOG.

BOG-52(2017)-09:

DPC for Officers.

In the Model Recruitment Rule for Non-Teaching posts circulated by the Ministry of HRD vide letter No.F.33-2/2013-TS.III dated 05.02.1014 and subsequently adopted by the BOG vide Resolution No. BOG-40(2014)-08 dated 09.05.2014, there are provisions of automatic up-gradation of pay scale of certain officer cadre posts, e.g. Dy. Registrar, Executive Engineer, SAS Officer etc.

It is proposed to grant up-gradation of pay scale through assessment by Departmental Promotion Committee (DPC) for all such posts in place of automatic up-gradation.

The Board approved the proposal and desired that the provisions under the Recruitment Rules be followed with internal assessment.

BOG-52(2017)-10: Advertisement for Faculty, Officers and Non-teaching Posts.

Out of total 485 sanctioned strength of faculty members, at present there are only 288 in service. It is proposed to advertise for the remaining 197 vacant faculty posts soon after the Nominee of Visitor is received.

Similarly, out of total 534 sanctioned strength of Officers and Non-Teaching posts, it is expected that there will be vacancy of 164 posts taking care of all the retirement cases up to 30.06.2017. So, it is proposed to advertise for these 164 vacant posts of officers and non-teaching staff.

 Proposal for extension of contractual services of Dr. Hrusikesh Mishra Visiting Faculty (under contract) in the department of Earth & Atmospheric Sciences.

The Institute requires services of eminent person who have specialised knowledge in the appropriate field of research and teaching. Normally we need the services of such person up to age of 65 years as per Government rules. This practice is followed in various IITs and NITs and other central funded Institutes.

Prof. (Dr.) Hrusikesh Mishra, Ph.D. (University of Wollongong, Australia) has rendered services to us for last three years after his superannuation from Coal India Limited. Dr. Mishra has an illustrious career in Coal India Ltd., and was active in publication and R&D activities before joining this department.

He is an eminent person in the field of Coal Petrology and its application to coal and hydrocarbon industries. He is the only Indian as a Full Member of International committee of Coal Petrology (ICCP). Dr. Mishra has developed a new Department of Earth and Atmospheric Sciences in the Institute. He teaches basic and practical classes along with participation in research in Coal Petrology. Four M.Sc. (applied Geology) students are doing project work under him. Another five students are expected to do project work in 2017-18 as number of M.Sc. Applied Geology students have increased substantially.

Besides, this Institute has no specialized faculty in Coal Petrography which has wide application in Departments of Mining engineering, Chemical and Metallurgical Engineering. He is actively associated in various projects in these departments that help in creating manpower to carry out research.

His appointment as Visiting Faculty on contract will expire on 23.03.2017 after completion of 3 years' of service. As per NIT Statutes Clause 28(1), his contract can be extended beyond 3 years up to a maximum 5 years with the prior approval of visitor on the recommendation of BOG. So, it is proposed to extend his service up to 31.12.2018 as his 5 years of service will be till 23.03.2019 and he will complete 65 years of age on 01.02.2019.

2) Recruitment for the post of Executive Engineer-Reg.

The present Executive Engineer of the Institute, Mr. S. P. Mohapatra, working as Head of Estate and Maintenance (EM), is going to superannuate on 28th February, 2017. The head of EM is responsible for all the civil work and electrical work both for on-going projects and the maintenance issues. It is essential to immediately fill the vacancy to be filled through an open recruitment process. It will also be appropriate to recruit a senior and richly experienced person who shall be able to handle the job effectively and supervise / guide the engineers and other subordinate staff for proper functioning.

It may be mentioned that there is no sanctioned superior position in the cadre (Superintending Engineer). It is proposed that the Executive Engineer post be recruited on Deputation / Contract for a period of 5 years and the maximum age limit to be fixed at 55 years against the prescribed maximum age limit of 40 years in the Recruitment Rule.

The Board did not approve the proposal and advised to recruit as per the existing criteria.
