#### A. GENERAL AND PROCEDURAL MATTERS.

BOG-63(2019)-01: Welcome to all the members to the meeting by the Chairman.

The Chairman welcomed all the members to the meeting.

BOG-63(2019)-02: Confirmation of the Minutes of the 62<sup>nd</sup> meeting of the BOG held on 08.12.2018 at New Delhi.

The minutes of the 62<sup>nd</sup> BOG meeting held on 08.12.2018 at New Delhi were sent to all the members for their comments regarding correctness of recording of the minutes. No comments were received from the members. The copy of the minutes was given in the Annexure for confirmation by the Board.

The Board confirmed the minutes with the following clarification:

1) The Board clarified its earlier resolution taken vide BOG-62(2018)-10 dated 08.12.2018 on the combination of past service of Prof. S.K. Behera, EC Department.

The Board did not accept the request of Prof. S. K. Behera to waive off Rs.2,71,667/-. If he pays this amount, his past service will be combined otherwise his pension will be counted from his date of joining NIT Rourkela under NPS/GPF as applicable.

#### B. POLICY AND IMPORTANT ADMINISTRATIVE MATTERS.

BOG-63(2019)-07: Appointment of Registrar.

Selection process consisting of oral presentation and personal interview for the post of Registrar was undertaken on January 07, 2019. The list of successful candidates recommended by the Selection Committee constituted by the BOG vide resolution No. BOG-62(2018)-22(2) was placed on the table by the Director for approval of the Board.

The Board thoroughly scrutinized the procedure adopted in the selection process and confirmed that every thing was in the order, and thereby approved the name of Prof. Pradip Kumar Das to be appointed as Registrar of the Institute on deputation basis for a tenure of 5 years at a pay scale of Level-14 under 7th CPC with pay protection on the basis of the recommendation of the Selection Committee.

BOG-63(2019)-08: Proposal for promotion of Professors to HAG scale.

The BOG vide resolution No.BOG-57(2017)-10, dt.28.11.2018 approved the Policy for selection of HAG Professor. Further, the Board vide resolution No. BOG-62(2018)-06 dt.08.12.2018 directed that the selection committee should be constituted taking experts from different Institutes and the selection process should be completed at the earliest and results may be put up in the next BOG meeting for approval.

Accordingly, the selection of HAG Professor were held during 3rd – 6th February, 2019. The list of subject experts and Visitor's nominees participated in the selection process of HAG Professors was given in the Annexure. The recommendation of the Selection Committee was put up by the Director on the table.

The Board was appraised that the entire selection process was followed as per the policy on implementation of HAG as approved by the Board vide No.BOG-61(2018)-15 dated 28.09.2018 and the resolution of NIT Council vide No.11.5 of NITs dated 18.07.2018.

The Board approved the list of subject experts for all departments and also approved the recommendation of the Selection Committee, for all the departments except that of Biomedical Engineering Department. The Director was advised not to open the sealed cover containing the result of Biomedical Engineering Dept. and to expedite to collect the reply from those who have not yet submitted their response on the issue of plagiarism. If necessary, ex perte decision may be taken after issuing notification in the newspaper.

The Board nominated Shri Raj Veer Singh, Executive Director (Personnel & Administration), SAIL, RSP, Rourkela as Nominee of BOG for the above selection committee in future recruitments.

BOG-63(2019)-10: Proposal for nomination of Board Nominee for Selection Committee for recruitment of Academic Staff (excluding the Director and the Deputy Director), or for promotion.

As per the Statutes Clause-23 and Sub-clause-5(a), the Selection Committee for recruitment of Academic Staff (excluding the Director and the Deputy Director) or for promotion shall be constituted as follows:

(1) Director or Deputy Director	-	Chairman
(2) Visitor's Nominee	-	Member
(3) Two nominees of the Board one being an Expert, but other than a member of the Board	rd -	Member

- (4) One expert nominee of Senate from outside of the Institute Member
- (5) Head of the Department concerned (for other than the post of Professor) - Member

It was proposed that any Professor of an Institute whose NIRF ranking is less than 50 under University category can be a Board nominee for the above selection committee in all future recruitments of academic staff.

The Board authorized the Director to suggest the list of subject experts from among Professors of Institutes of repute as Nominees of Board and go ahead with the selection process after getting the list approved by the Chairman of BOG. The list would be valid for 3 years.

BOG-63(2019)-11: Result of Departmental Promotion Committee (DPC) for Non-Teaching employees.

> The selection process for giving promotion to the eligible Non-Teaching employees of the Institute under Departmental Promotion Committee (DPC) was scheduled during 7th - 26th February, 2019 as per the revised Recruitment Rules (RRs) for Non-Teaching staff of NITs circulated by the MHRD vide no.F.33-2/2012-TS.III, dt.20.12.1017 and subsequently adopted by the BOG vide resolution No.BOG-58(2018)-06 22.01.2018.

> The list of successful candidates recommended by the committee was placed on the table for approval of the Board for the officers only and for information of the Board for rest of the Non-Teaching employees.

> The Board approved the results of DPC for officers and noted results of rest of the non-teaching employees.

BOG-63(2019)-12: Advertisement for Faculty position.

> Out of total 485 sanctioned strength of faculty members, at present there are only 308 in service. It was proposed to advertise for the remaining 177 vacant faculty posts.

> The Board approved the proposal. The Board also opined that faculty selection should be carried out at regular interval. initiate this process, taking prior approval of the Board is not necessary. The Board should only be informed.

BOG-63(2019)-13: Revision of Allowances of Faculty, Scientific/Design Staff and Non-Teaching Staff in Centrally Funded Technical Institutions as per recommendations of 7th CPC.

> The MHRD vide letters F.No.33-1/2019-TS.III (Pt.I) dated 05.02.2019, TC Section letter No.15-4/2017-TC dated 31st January, 2019 and copy of the corrigendum vide letter No.15-4/2017-TC dated 1st February, 2019 (copy enclosed in the Annexure) has conveyed the decision of Govt. of India for implementation of revision of allowances of Faculty, Scientific/Design Staff and Non-Teaching Staff in Centrally Funded Technical Institutions on the basis of recommendation of 7th CPC w.e.f. 1st July, 2017. It was proposed for the approval of the Board for its implementation.

> Based on the recommendation of FC vide resolution No.FC-48(2019)07 dated 28.02.2019, the Board approved the revision of Allowances of Faculty, Scientific/Design Staff and Non-Teaching Staff of the Institute as per recommendations of 7th CPC w.e.f. 1st July. 2017 such as Transport Allowance, Children Education Allowance, House Rent Allowance and Non-Practicing Allowance. The Board

further decided that other allowances related to TA/DA & LTC etc. will be effective from the date of the approval of the Board i.e. 28.02.2019 (i.e. for the journey performed on or after 28.02.2019).

BOG-63(2019)-14: Case of Prof. P. Kumar, Associate Professor, PH and Prof. B. Mahanandia, Asst. Professor, PH.

As per the directive of the BOG vide resolution No BOG-61(2018)-03[2(a)], and No BOG-62(2018)-03[2(b)], the facts presented by Prof. P. Kumar, Asso. Professor, PH and Prof. B. Mahanandia, Asst. Professor, PH were examined and a consolidated report with the comments was enclosed in the Annexure.

The Board decided to issue show cause notice to the concerned faculty members for the charge of submitting wrong information while filling in application form for the last faculty selection.

BOG-63(2019)-15: Proposal to provide opportunity to the employees who joined the Institute prior to 01.01.2004 to switchover from CPF to GPF-cum-Pension scheme.

Against the case filed by 25 employees of the Institute for conversion from CPF to GPF-Cum-Pension, the Hon'ble High Court, Odisha vide SI. No of Order: 09, dated 09.04.2018 gave order that:

"Employees of the Institute appointed prior to 01.01.2004 will be governed by the Central Civil Services (Pension) Rules, 1972 and General Provident Fund (Central Services) Rules, Rules 1960 and employees appointed on or after 01.01.2004 will be governed by the New Pension Scheme of Central Government."

The copy of the judgment of Hon'ble High Court, Odisha was given in the Annexure. However, a letter dated 26.04.2018 has been received from MHRD wherein it has been mentioned that that:

"The Hon'ble Court while delivering the judgement failed to appreciate the scheme of NITSER Act and its First Statutes. The National Institutes of Technology (NITs) are autonomous Institutions governed by NITSER Act 2007 and statutes framed under the Act. The NITs are fully funded institution of national importance run by the Government of India along with other equally established institutions. All the Institutions are following rules & regulations issued by the GOI from time to time.

The IF Division of MHRD has summed up the instructions of Department of Pension and Pensioner Welfare regarding switching over from CPF to Pension-cum GPF Scheme. It was the policy decision taken by the Central Government which is equally applicable on all the autonomous bodies (including NITs) issued vide letter no. F.19-20/2005 dated 22<sup>nd</sup> February,

2006 that the employees who entered into service on or before 31.12.2003 and are governed by the CPF scheme, are not eligible for switch over to the GPF-cum-Pension Scheme. They will continue to be governed by the CPF scheme".

Accordingly, as per directive of the Board vide its resolution No. BOG-60(2018)-10, dated 22/06/2018 on the judgment of the High Court dated 09/04/2018 for the subject of conversion of Contributory Provident Fund (CPF) to GPF(General Provident Fund)-Cum-Pension scheme, an appeal has been filed with the Hon'ble High Court of Odisha bearing number WA 333 of 2018 (NIT vs. Dr. Abanti Sahoo & others). Notice on the question of limitation has been issued on 17.01,2019.

The Board decided to take the opinion of a Senior Lawer of High Court to assess the chances of winning the case based on the facts, legal issues involved and other relevant judicial pronouncements before adopting future course of action.

### BOG-63(2019)-17: Proposal for Renaming of the Alumni Relations & Resource Generation as "Alumni, Industry and International Relation (AIIR)".

Dean (AR) had given a proposal for renaming the "Centre for Alumni Relations and Resource Generation" as "Centre for Alumni, Industry and International Relation" (AIIR) in which he clarified that Alumni, Industries, and International Educational Institutes/Universities are external to the Institute and many alumni are associated with/working with Industries, and International Educational Institutes/Universities. Hence, these three entities come under a single umbrella. So, it was proposed to put these entities under a single functional unit. Copy of the request letter from Dean (AR) was given Annexure.

The Board approved the proposal.

#### BOG-63(2019)-18: Constitution of Committee for External Peer Review of NITs.

As directed by the MHRD vide letter No. F.No.35-3/2018-TS.III dated 02.01.2019 to constitute a committee as per the recommendations of the Kakodkar Committee which were accepted by the NIT Council in its 7th meeting held on 18th Oct. 2013, there has to be external review of NITs and IIEST, Shibpur. As per recommendations, a minor review once in 3 years and a comprehensive review once in 6 years, are to be carried out by all the Institutes. For this purpose, the composition of the committee was also approved, which comprise two reputed persons from academia, two experts from the industry, one eminent citizen and one NIT Alumni. Above committee is to be set up by BoGs of NITs/IIEST with the approval of the Standing Committee of Council and the term of Committee members would be 9 years with 1/3<sup>rd</sup> of its members retiring every 3<sup>rd</sup> year.

#### A) Resignation

He was relieved from the Institute service with effect from the last working hours on 12/12/2018 pending approval of the BOG.

The Board approved the technical resignation of Prof. Saikat Sarkar, Asst. Professor, CE Department.

2) Dr. Rahul Soangra [EC-1151241] had joined this Institute Service on 24/08/2015(FN) in the Department of Biotechnology & Medical Engineering. On joining he was credited with CL @ 8/12\*4 = 2.6 rounded to 3 days. He had applied for CL from 21/09/2015 to 23/09/2015(Annexure-I). The last working day of Prof. Soangra at this Institute was 18/09/2015.

On 22/09/2015 he had sent an email to the then HOD that due to health issues there will be delay from his side to join back Institute duties. He had submitted a medical certificate certifying that he was suffering from lumbigo (Annexure -II).

HOD then asked him to extend his leave online through another email (Annexure-III). However, Dr. Soangra still did not return to duty. On 30/10/2015, HOD sent him another email to intimate to the Institute when he will be joining back into the Institute service (Annexure-IV).

Subsequently, he resigned from the post of Asst. Professor (on contract), Dept. of BM via email to HOD on 09/11/2015 (Annexure-V).

Prof. Soangra has not been paid anything including salary since his joining.

Letter to Chairperson for accepting his resignation w.e.f. 18/09/2015 was sent on 05.12.2015 (Annexure-VI). However, the Chairperson had asked for a clarification on 17.12.2015 as to whether Prof. Soangra has been relieved from his position at NIT Rourkela (Annexure-VII).

Accordingly, a clarification letter was sent on 06/01/2016 to the then Chairperson stating that his last working day in the Institute was 18/09/2015 and that he was not relieved from the Institute service officially (Annexure-VIII).

Reply from the then Chairperson is still awaited.

A letter was then sent to Prof. Soangra on 21.07.2017 for depositing the amount of Rs. 65,050/- into the Institute account in the form of a Demand



Draft in lieu of one month notice period and to submit all clearances (Annexure-IX).

No reply has been received from his end till date.

In view of the above, the following inferences may be drawn:

- 1. He has served the Institute only for 26 days for the period from 24/08/2015 to 18/09/2015.
- 2. Since, he served for less than one month, he is not eligible for CL. Hence, his relieving date may be considered as 18/09/2015.

Therefore, it was proposed to relieve him officially w.e.f. 18/09/2015(AN) condoning 4 days of shortfall of salary in lieu of notice period of one month subject to getting clearances from all sources and close the chapter pending for more than 3 years.

#### D. MISCELLANEOUS ITEM:

BOG-63(2019)-21:

Representation of Dr. Smrutisiksha Bal, Sr. Scientific Officer. Board vide resolution BOG-58(2018)-06 has approved the proposal in principle for adoption of revised Recruitment Rules (RR) for non-teaching employees and advised to go for advertisement after clarifying all anomalies.

In the old RR, the Grade Pay for the post of Sr. Scientific Officer was 6600/- (PB-3) and similarly the Grade Pay for Sr. Medical Officers was 7600/- (PB-3). However, in the revised RR the Grade Pay for the post of Sr. Scientific Officer has been prescribed as 7600/- and for Sr. Medical Officer the Grade Pay has been prescribed 6600/-(reduced). As there are incumbents in these posts, the matter was referred to Anomaly Committee constituted by MHRD for necessary clarification.

Meanwhile, Dr. Smrutisiksha Bal who is working as Sr. Scientific Officer in the Grade Pay 6600/- represented for grant of Grade Pay 7600/- automatically based on the revised RR. The matter was put up to Director with the remark that as the discrepancy in Grade Pay of the post is under consideration of Anomaly Committee, the decision on her representation could be taken only after receiving of necessary clarification. Further, the change of Grade Pay of an officer needs to be considered by Departmental Promotion Committee (DPC) and approval of Board. However, the matter was referred by Director to Vetting Committee, which in turn recommended that the change of Grade Pay of Dr. Bal is matter of mapping and need not to be clubbed with DPC.

The report of the Vetting Committee was given in the Annexure.

The Board vide resolution No.BOG-52(2017)-09 dated 14.02.2017 approved that all the up-gradation of pay scale of officer cadre posts should be through internal assessment instead of automatic up-gradation.

The Board vide resolution No.BOG-62(2018)-20 dated 08.12.2018 directed that since the MHRD is examining the report of the Oversight

Committee, the institute should wait till the final RR is approved by MHRD

However, the Board was requested to reconsider its earlier decision and allow to implementation of Vetting Committee recommendation.

The Board decided to upgrade the pay scale through internal assessment.

1) Amendments in the implementation of National Pension System (NPS).

Ministry of Finance, Govt. of India vide Gazette Notification F.No.1/3/2016-PR dated 31.01.2019 has made partial modification of para 1(i) of its own earlier Gazette Notification No.5/7/2003-ECB-PR dated 22nd December, 2003, based on the Government's decision on 6th December, 2018 on the recommendations of a Committee set up to suggest measures for streamlining the implementation of National Pension System (NPS).

As per earlier notification the monthly contribution is now 10% of the salary and DA to be paid by the employee and matched by the Central Government. As per new notification, the monthly contribution would be 10% of the Basic Pay plus DA to be paid by the employee and 14% of the Basic Pay plus DA by the Central Government.

The modifications shall come into force with effect from 1st April, 2019. Copy of the Notification is attached. Accordingly, it was proposed to implement the above Government notification.

The Board decided to wait till a notification from MHRD is received in this matter.
