C. RESEARCH STUDIES:

2014-49-Senate-08: Recommendation of RPEC on new Enrolment, Provisional Registration and Registration of PhD and M. Tech(Res) students:

The Senate noted the proposed dates for admission, registration and starting of classes for Autumn 2014-15 with minor changes in the proposed date of admission to M Tech programmes as given in the annexure.

ITEM – 2: Proposed change in the course work requirement for Ph D students.

It was observed that the minimum coursework requirement mentioned in the PhD regulations need to be revised.

The Senate reviewed the coursework requirement for PhD students and decided the following:

- a) Minimum coursework requirement for PhD students of any discipline will be 18 credits.
- b) Out of these 18 credits assigned courses, up to 12 credits of the courses with B grade or higher can be exempted if completed during



M.Tech, M.Tech(Res) or M.Phil degree and at least 6 credits of new courses are to be assigned by the DSC to these students.

- c) For the students (PhD, M.Tech(Res) and M.Tech) availing Scholarship (any type):
 - (i) Absence upto 15 days in an Academic year will be treated as leave and there will be no deduction of scholarship.
 - (ii) Absence for 16 20 days, scholarship will be deducted at the rate of per day.
 - (iii) Absence beyond 20 days, for one day of absence two days of scholarship will be deducted.
