#### 2018-76-Senate-05: Academic Calendar for the session 2018-19.

### 2018-76-Senate-06: Proposal for Part-Time Programs for Industry Employees.

It is being observed that there is huge demand for part-time programs from the employees of various local industries like SAIL, NTPC, NSPCL, L&T, Vedanta, etc. Introduction of part-time programs to cater to their need has also a lot of scope for generation of revenue for the Institute which has become a call of the current time.

In view of above, it is proposed to introduce self-financing part-time programs in M. Tech. / MBA and Ph. D for the working employees of the local industry and other Govt./Pvt. organisations from the Autumn 2018-19 semester.

Schedule and Curriculum may be finalized by the Dean (AC) in consultation with Chairman, Time Table Committee and Chairman, Curriculum Development Committee, respectively. He may also propose Eligibility Criteria and Fee-Structure for the above programs

Senate approved the proposal in-principle to start from Autumn 2018-19. Dean (AC) and Chairman, Curriculum Development Committee were advised to put up a detailed proposal with eligibility criteria, fee structure, honorarium to faculty and associated staff, etc. in the next Senate meeting.

#### 2018-76-Senate-07: Policy for pursuing various programs by the Institute employees.

The Senate, vide Resolution No. 2018-75-Senate-11.1, dated 11/04/2018 has approved the general guidelines proposed by Prof. J. K. Satapathy Committee allowing the institute employees to pursue higher studies in various programs of the Institute.

- b. To run Integrated M. Sc. with new curriculum from 7<sup>th</sup> semester w.e.f Autumn 2018-19.
- c. Inclusion of Fourier Series and Fourier Transformation.
- d. Common and compulsory Mathematics course for Ph. D students.

# 2018-76-Senate-09: Regulations for Minor Degree for B. Tech. students.

The Senate, vide resolution No. 2017-69-Senate-20, dated 28/02 and 01/03/2018 has approved the proposal for offering Minor Degree to B. Tech students admitted from 2017-18 batch onwards. The proposed regulations for the same was put up on the table.

Senate approved the proposal with following additions:-

- a. There should not be any backlog to be eligible for applying for registration. In case of any backlog or CGPA falling below 7.5 after registration, registration will be cancelled
- b. No. of seats will be 40 each in CS, EC, EE and ME and 30 each in rest of the branches.
- c. Provision of Minor Degree for Dual Degree, Int. M. Sc. And B.Arch students to be discussed in the next Senate meeting.
